I. Project Information

This bidding project is for the Design Review of China-Laos 500kV Grid Interconnection Project (Laos Section). The Employer is Electricite du Laos Transmission Company Limited ("EDL-T"), and the funding of the Project has been secured. The Project has met the conditions for bidding, and is now open for public bidding. Chuangxin (Laos) Construction and Investment Development Co., Ltd., the Bidding Agent entrusted by the Employer, now invites interested and eligible entities (hereinafter referred to as the "Bidder") to submit bids, and the Project adopts a post-qualification mechanism.
